#### c) Membership Report

Current membership currently stands at 1,653 based on payments. This is an increase of approximately 300 since last year. VE presented a proposed new structure for membership signup which includes several new levels with fees ranging from free to £200. The aim is to gather much more information on our members. Once complete members will be asked to update/confirm their details when registering for an event or the exam. The work is currently out to tender.

#### 4. Accreditation Committee

On Stuart Allen's behalf, Honey Thomas informed members that the new reaccreditation online points system was launched this year and has been well received. This year saw the launch of the new Physician exam which is tailored to those earlier on in their career. This exam is tailored to the curriculum. Exam pass rates remain consistent. Webinars have increased and are becoming more popular each time. The next webinar is a practical approach to left bundle pacing on 29th November.

#### 5. Education Committee

JP was formally thanked for all the hard work on today's successful symposium as well as the previous simulation and sessions held earlier in the year. JP presented a financial overview of the events. The aim is to break even / reinvest any surpluses back into events. The plan for 2025 is; Sessions: 4-6th March in Edinburgh, Simulation: June in South Wales, and Symposium: November in London.

#### 6. Audit report

Anish Bhuva presented preliminary data. This data will be publicly shared when ready. NHS England has asked NICOR to collect PROMS for AF ablation. If anyone wishes to be involved please do get in touch. The next step is to look at procedural complications. Resources are being received to continually improve data capture.

#### 7. Research Report

Ross Hunter presented the following report:

  - Redo PVI vs Endo & Epi ablation, 120 pt, PI JS
- ORBICA-AF: Blinded PVI vs DCCV for persistent AF
  - o 208 pts, PI MF

#### Research: works in progress

- BHRS Director of larger UK studies
- Focus on multicentre RCTs > 100 patients
- Showcase UK research
- Cls to 'advertise' studies
- Other centres and patients can find studies
- Some Cls have responded, trying to get consistent dataset re-trials for tangled web
- BHRS study groups focused on specific areas
- Purpose to initiate and support studies
- Start with two niche groups:
- VT ablation
- Extraction
- Interest form some Pls to join a group
- Hope to expand from there
